International Interclub Competition for Ice Dance in the categories:

Senior, Junior, Advanced Novice and Basic Novice.

Rules per category:

Senior: The short and free dance are to be skated in accordance with the ISU Technical Rules Ice Dance for this season 2011-2012, for specific details see the most recent communications 1670, 1677 and 1686.

Junior: The short and free dance are to be skated in accordance with the ISU Technical Rules Ice Dance for this season 2011-2012, for specific details see the most recent communications 1670, 1677 and 1686.

Advanced novice: Two pattern dances and the free dance are to be skated. In accordance with rule 639 paragraph 1 the pattern dances for season are:

Group 1: # 4 European Waltz #20 Tango

Group 2: #3 Rocker Foxtrot #9 Starlight Waltz

One group of two pattern dances shall be drawn before the first practice of the competition out of the two groups. The free dance is to be skated in accordance with the ISU Technical Guidelines for specific details see the most recent communications 1649, 1670, 1677 and 1686.

Basic Novice: Two pattern dances and the free dance shall be skated. The following pattern dances are to be skated: **#1 Fourteen Step** and **#4 European Waltz**.

Timetable: The timetable will be distributed in writing after registration is completed.

Expenses: Competitors are responsible for their own expenses.

Accommodation: Competitors must make their own reservations for accommodation. For more information about local hotels, please contact the organizing committee.



- Calculation:** The IJS will be used to calculate the results.
- Judges:** Participating clubs or associations are required to supply one judge, technical controller, technical specialist, data operator or video cutter per team with the minimum qualification "National Championships" who is trained in the new ISU Judging System.
- Entry fees:** €60,- per couple payable at time of registration to the following account:
Westfriesche Kunstrij Club, Hoorn, The Netherlands. Bank Identification Code (BIC): RABONL2U; International Bank Account Number (IBAN): NL65 RABO 0111 5025 19.
If no judge is supplied the registration fee per couple will be €100, -. The organizer withholds the right to choose the panel of judges. Hotel and travelling costs for judges must be paid by the registering club or association. Concerning meals, lunch and dinner will be provided for judges and technical panel on the competition days by the organizing committee.
- Registration:** Your registration must include for each competing couple first and last names, date of birth, club and country affiliation, competing categories and planned program sheets.
- Music:** CD should be labeled with names, club, country and category. A separate cd must be provided for each program
- Responsibility:** In accordance with ISU Regulations Rule 119 the organizer may not be held responsible for eventual accidents or other damages to participants, officials or third parties. The organizing committee withholds the right to cancel (parts of) the competition when circumstances therefore arise without being liable for any costs etc. made by entering teams, officials and accompanying persons.
The organizing committee has the right to decline entries because of the time-schedule.
